Subject: Bill 242, Safer Municipalities Act, 2024

The following resolution, adopted by City Council at its meeting held on January 13, 2025, is forwarded for your consideration.

# Whereas:

- 1. A municipality's parks and open spaces are critical infrastructure that support a strong community, and the public's shared and safe use of the municipality's parks and open spaces is integral to ensuring that support.
- 2. Ontario's municipalities are struggling to maintain their parks and open spaces for their shared and safe use by the public as a result of the increasing proliferation of encampments and illicit activities related thereto.
- 3. Municipalities that enforce their standards regulating or prohibiting encampments in their parks and open spaces must have regard to the availability of shelter space for those who need shelter.
- 4. On January 27, 2023, Justice Valente of the Ontario Superior Court of Justice rendered his judgment in *Waterloo (Regional Municipality) v. Persons Unknown and to be Ascertained* (2023), [2023] O.J. No. 417 (Waterloo Decision) which declared that the municipality's by-law violated section 7 of the *Charter* and was therefore inoperative insofar as it applied to prevent encampment residents from erecting temporary shelters on a site when the number of homeless individuals in the region exceeded the number of accessible shelter beds.
- 5. The Waterloo Decision's analysis of the adequacy of shelter beds suggests an unworkable and unclear standard that goes beyond the number of shelter





spaces and that includes the requirement to provide shelter spaces that must accommodate illicit drug use and other activities that could put shelter residents, workers and volunteers at risk. The result is that municipalities are impaired in their enforcement of their standards and have lost or are losing control of their parks and open spaces.

- 6. On December 12, 2024, the Honourable Paul Calandra, Minister of Municipal Affairs and Housing, introduced Bill 242, Safer Municipalities Act, 2024. Among its various initiatives, Bill 242 proposes to amend section 2 of the Trespass to Property Act by adding aggravating factors that must be considered in the court's determination of a penalty under that section. However, the key challenge is that a municipality's exercise of its rights at common law and under section 9 of the Trespass to Property Act to remove encampments from the municipality's parks and open spaces remains potentially subject to the unworkable and unclear standard for the adequacy of shelter space suggested by the Waterloo Decision.
- 7. In these circumstances, municipalities need provincial legislation that clearly defines a workable standard for shelter space for the purposes of a municipality's jurisdiction to enforce its standards regulating or prohibiting encampments in its parks and open spaces.

# Now therefore, be it resolved:

- 1. That the provincial government be respectfully requested to amend Bill 242 to clearly define a workable standard for shelter space for the purposes of a municipality's jurisdiction to enforce its standards regulating or prohibiting encampments in its parks and open spaces.
- 2. That, without limitation, Bill 242 provides that a municipality will have met the standard for shelter space for the purposes of the municipality's jurisdiction to enforce its standards regulating or prohibiting encampments in its parks and open spaces:
  - a) despite the establishment and enforcement of shelter rules including rules that prohibit drug use and other activities that could put shelter residents, workers and volunteers at risk; and
  - b) if an official designated by the municipality is satisfied that the number of available shelter spaces is at least equal to the aggregate of the number of individuals actually seeking shelter and the number of individuals against whom the municipality is planning to enforce its standards regulating or prohibiting encampments in its parks and open spaces.

The BlueBox and recycling are essential to many of your citizens. In Northeastern Ontario, municipalities will transition to Full Extended Producer Responsibility (EPR) for the household BlueBox program over the next few years. EPR will be important for the Province of Ontario, as producers/stewarts will soon create a sustainable circulatory economy for the paper, packaging and products a household recycles.

Producers/Stewarts are not responsible for products purchased within the Industrial, Commercial, and Institutional (ICI) sectors. Products recycled at home are disposed of by an ICI-funded program or landfilled.

All municipalities are concerned with the lifespan of landfills, and FONOM believes it is important that the Province and the Producers/Stewarts start discussing the transition to a producer-funded EPR system for the recyclables generated by the ICI Sector.

We ask your council to consider supporting the draft resolution below.

I am happy to answer any questions you may have.

WHEREAS under Ontario Regulation 391/21: Blue Box, producers are fully accountable and financially responsible for their products and packaging once they reach their end of life and are disposed of, for 'eligible' sources only;

AND WHEREAS 'ineligible' sources which producers are not responsible for including businesses, places of worship, daycares, campgrounds, public-facing and internal areas of municipal-owned buildings and not-for-profit organizations, such as shelters and food banks;

AND WHEREAS should a municipality continue to provide services to the 'ineligible' sources, the municipality will be required to oversee the collection, transportation, and processing of the recycling, assuming 100% of the costs;

AND WHEREAS these costs will further burden the municipalities' finances and potentially take resources away from vital infrastructure projects;

THEREFORE BE IT RESOLVED THAT the Council of the \_\_\_\_\_\_ hereby request that the province amend Ontario Regulation 391/21: Blue Box so that producers are responsible for the end-of-life management of recycling products from all sources;

AND FURTHER THAT this resolution be forwarded to the Honourable Andrea Khanjin, Minister of the Environment, Conservation and Parks, Your Local MPP, AMO, ROMA and FONOM

Re: Solve the Crisis

Please be advised that the Council of the Regional Municipality of Waterloo at their regular meeting held on September 25, 2024, approved the following motion:

Whereas there is a humanitarian crisis in cities, large and small, urban and rural, across Ontario. We need immediate action at all levels of government, starting with the Province; and

Whereas the homelessness, mental health and addictions crisis continues to grow with 3432 drug related deaths in Ontario in 2023 as well as with an estimated 234,000 Ontarians experiencing homelessness and over 1400 homeless encampments across Ontario communities in 2023; and

Whereas the province has provided additional funding for mental health, addictions and homelessness programs, including the recently announced Homelessness and Addiction Recovery Treatment (HART) Hubs, it does not adequately address the growing crisis and the financial and social impact on municipalities and regions across the province; and

Whereas municipalities and regions are stepping up and working with community partners to put in place community-specific solutions to address this crisis, but municipalities and regions lack the expertise, capacity, or resources to address these increasingly complex health care and housing issues alone; and

Whereas this is primarily a health issue that falls under provincial jurisdiction and municipalities and regions should not be using the property tax base to fund these programs; and

Whereas there is no provincial Minister focused on this crisis leading to unanswered questions that span over a dozen ministries, and a lack of support to manage the increasing needs of those who are unhoused.

Now Therefore be it resolved that the Region of Waterloo supports the Solve the Crisis Campaign;

And calls on provincial and federal governments to commit to immediate action to solve the Humanitarian Crisis that Ontario is facing as the numbers of unhoused individuals and those suffering with mental health & addictions grows exponentially;

AND that the province officially makes Homelessness a Health Priority;

AND appoints a responsible Minister and Ministry with the appropriate funding and powers as a single point of contact to address the full spectrum of housing needs as well as mental health, addictions and wrap around supports;

AND request that the provincial government strike a task force with broad sector representatives including municipalities, regions, healthcare, first responders, community services, the business community and the tourism industry to develop a *Made in Ontario Action Plan*:

AND that this provincial task force reviews current programs developed by municipalities, regions and community partners that have proven successful in our communities, to ensure that solutions can be implemented quickly and effectively to tackle this crisis.

AND provides the adequate, sufficient and sustainable funding to ensure that municipalities have the tools and resources to support individuals suffering with mental health and addictions, including unhoused people and those from vulnerable populations that may be disproportionately impacted;

And that this Council calls on the residents across the Region of Waterloo to join us in appealing to the provincial and federal governments for support by visiting SolveTheCrisis.ca and showing your support;

Whereas infrastructure and policing are inherently limited in their effectiveness at reducing speed and distracted driving, and entirely ineffective at reducing impaired driving;

Therefore be it resolved that the City of Woodstock calls on the Provincial and Federal governments to do everything in their power to limit speeding, distracted driving, and impaired driving, and thereby reduce collisions, injuries, and fatalities in our communities; and,

That the City of Woodstock specifically requests that the Government of Ontario take action to implement the rural road safety program that Good Roads has committed to lead, which will allow Ontario's rural municipalities to make the critical investments needed to reduce the number of people being killed and seriously injured on Ontario's rural roads; and,

That City of Woodstock Staff work with Oxford County and all Oxford municipalities on the feasibility of implementing a long term Vision Zero Policy and the Good Roads Rural Road Safety strategy across all of Oxford; and,

WHEREAS THE TransCanada Highway is the road system meant to move goods and people across the country, but it is no longer equipped to do that safety in Northern Ontario.

NOW THEREFORE BE IT RESOLVED THAT the Council of the Township of Coleman herby support the Northern Highway Safety Plan proposed by MPP Guy Bourgouin, MPP Lise Vaugeois and MPP John Vanthof which includes the following;

#### Immediate Actions:

- Require all new drivers to be tested by MTO-certified inspectors instead of third-party companies.
- Return highway maintenance operations to the MTO while working with northern contractors.
- Increase staff at inspection sites, weigh scales, and OPP traffic enforcement.
- Expedite the 2+1 highway pilot project and use excavated material to build additional rest stops and parking areas.

#### Short-Term Improvements:

- Mandate snow tires for all passenger vehicles in Northern Ontario.
- Ensure driving schools comply with the MELT training system and improve MELT to include winter driving
- Address the abuse of "self-insurance provisions" and ensure fair payment for tow truck operators and service providers.
- Require all commercial vehicles to have dash cams.
- Increase the use of traffic cameras and photo radar to reduce speeding.
- Promote rail transport to reduce commercial truck traffic on northern highways.
- Upload connecting links back to the provincial highway system for consistent maintenance.
- Upgrade and expand rest stops with heated washrooms to meet traveler needs.
- Provide compensation to municipalities for damage to local roads caused by highway detours.

#### **Long-Term Solutions:**

- Widen and pave all shoulders on Highways 11 and 17.
- Convert Highways 11 and 17 into divided four-lane highways where possible or implement a continuous threelane system if the 2+1 project proves successful.

AND FURTHER THAT a copy of this resolution be forwarded to the Minister of Transportation; the Minister of Municipal Affairs & Housing; all Provincial Leaders; the Temiskaming Municipal Association; the Federation of Northern Ontario Municipalities (FONOM); the Northwestern Ontario Municipal Association (NOMA); and all municipalities in Ontario.

# NORTHERN HIGHWAY SAFETY PLAN

#### Introduction

Safety on the TransCanada Highways 11 and 17 continues to be the number one concern for most residents of Northern Ontario because they are our main streets. We use these highways to get to work, school, hockey, and medical appointments, but we share them with thousands of cross-country commercial trucks. As a result, Northern MPPs have had a lot to say over the years about the state of highways in the North and for good reason.

Years ago, the problem was proper and consistent winter maintenance. The Liberal government in power at the time claimed everything was fine, so MPP Vanthof's office created the Northern Road Report to show that it wasn't. The Minister of Transportation (MTO) demanded that the report be taken down, but in the end the Northern Road Report helped prove that even when contract requirements were being met, people were still being put at risk. As a result, the government of the day was forced to make changes to the system.

MPP Bourgouin introduced legislation to make maintenance standards the same across the TransCanada system, so that It north of North Bay would be maintained to the same standard as south. The legislation was defeated, but the government did create a separate standard for the northern portion of the TransCanada highway. MPP Bourgouin has also introduced other pleces of legislation regarding driver training and not being able to pass on double solid lines. This was defeated, but he remains committed to finding ways to solve safety issues the same as his fellow Northern MPPs. Similarly, MPP Vaugeois introduced a motion that driver testing be taken back by the MTO which would have been an effective way for the government to control the standard of drivers on the roads. All three members have been vocal in the legislature regarding highway safety throughout their careers.

We are once again facing a highway safety crisis, one that we believe requires a plan designed by Northerners for Northerners. It contains clear goals that we can push government of whatever stripe to implement for all our families.

#### **Current Situation**

Currently some poorly trained commercial vehicle drivers and the companies they work for are putting all other drivers at undue risk, incidents have been easy to track on social media. Investigative reports on the problems in commercial truck training and licensing, and from the Auditor General of Ontario identified this problem as far back as 2018. We, Northern MPPs have mentioned this issue many times in the legislature. The response from the government has been that these are the safest roads in North America, and that they are looking into the matter.

Regardless of political stance, we hope that we can all agree that one of the basic jobs of any government is to ensure that people who are issued a driver's license are capable of safely driving the vehicle for which they are licensed. There are over a hundred companies in Ontario who recruit, train, and license their own drivers and they can issue Ontario licenses to them. These are among the worst offenders. Of course there are still good driving schools, and companies that provide excellent training programs to their new drivers, but not all of them. Change needs to happen in the immediate and long term, and we are proposing a plan to address these needs. First, there needs to be immediate action by the Ministry to ensure that only properly- trained drivers are graduating by appointing employees of the MTO to conduct driving tests for all new commercial vehicle drivers before they can receive a license.

#### Immediate Ask

 Have all new drivers tested by MTO certified inspectors, not third-party private companies. If their student drivers can't pass a legitimate road test, then these driving schools will be forced to change how they conduct business.

# Short-Term

- Return the management of highway maintenance operations to the MTO, while working with contractors and providers throughout the North.
- Increase staffing at scales and inspection sites, as well as OPP Traffic enforcement to ensure the laws currently in place are being followed.
- Expedite the 2+1 pilot project and the construction of rest stops. Use the fill that is dug out to rebuild sections of the highway to create parking pull offs.

#### Medium-Term

- Make snow tires mandatory for all passenger vehicles registered in Northern Ontario.
- Ensure that driving schools comply with the current MELT training system.
- Reform Issues within MELT Itself and expand requirements to include winter driving training.
- Address the current abuse of "self insurance provisions" and ensure tow truck operators and other service providers can get paid for services from these schemes.
- Require that all commercial motor vehicles have dash cams.
- Increase the number of cameras and photo radar to slow down traffic.
- Emphasize rail to move goods so not as many loads must travel on the highway.
- Return connecting links to the provincial highway system so that maintenance is uniform.
- Better equip and increase the availability of rest stops with heated, maintained washrooms.
- Direct the cost of repairing damage to municipal roads caused by detour traffic from highway closures to the MTO.

# Long-Term

- Widen and pave all shoulders on Highways 11 and 17.
- Make Highway 11 and 17 a divided four-lane highway wherever possible.
  - o If the 2+1 pilot proves successful, a continuous three lane would be a good intermediate step. The TransCanada Highway is the road system meant to move goods and people

# **BACKGROUND**

The Pinehill Cemetery was transferred into the Town of Mattawa's care in 2017 and the Cemetery Administrator, Cemetery Clerk and Public Works Supervisor has been updating the paperwork and the cemetery since that time.

# **ANALYSIS & DISCUSSION**

Currently in the Pinehill Cemetery there are four sections: Section A and Section B, which are referred to as the old section; Section C which is the newer section just driving into the cemetery off of Eighth Street and Section D which is against the fence. Sections A, B & C are regular casket plots which are 4'x8' in size. Section D is the cremation plots which are 2'x4' in size. We currently have 12 cremation plots left for sale.

Staff have looked into the granite columbariums, which we do have room to add, but feel it is not required at this time until we sell more of the cremation plots. We will keep monitoring the plots left and bring forward any recommendations at a later date.

There is one pine tree within the cemetery limits that is losing limbs and beginning to rot in the middle so staff is working on getting quotes for removal which will be brought to Council once we have everything in place. This tree does need to be removed before any more limbs fall and destroy the monuments in the area or worse.

The gates to the cemetery are currently closed to the public and will open in May once the snow is all gone from the site. Before that time the Cemetery Clerk and Public Works Supervisor will do a walk-through of the cemetery for any repairs that are required to the fencing and grounds.

# RECRUITMENT EFFORTS

The Mattawa Fire Department has been in the process of recruiting new firefighters since February by promoting the Fire Department through social media platforms and hand delivering recruitment flyers throughout town. We are currently in the process of finalizing the applications and onboarding new recruits. 5 individuals are slated to be interviewed April 3, 2025.

# FIREFIGHTER TRAINING PLANNING AND DZ LICENSING EFFORTS

Since 2024, the Mattawa Fire Department has increased their training fundamentals that go above training on Wednesday evenings. The Mattawa Fire Department is in the process of onboarding our firefighters with the educational requirements to meet the National Fire Protection Association (NFPA) standard that the OFM has mandated by July 1, 2026.

The Mattawa Fire Department has initiated the process to have its firefighters successfully complete their DZ licensing to be able to operate the firetrucks professionally and safely and be compliant with MTO standards. With this, the Town of Mattawa has agreed to enroll its' firefighters in a DZ course. This course is approximately \$1500 per person plus tax through the Transport Training Centres of Canada.

# ANALYSIS AND DISCUSSION

#### **Public Works**

#### Snow Removal

Nice to see the time change and the weather shift away from a busy winter season. Winter this year was a little more robust than last. Snow removal operations on Saturday and Sunday mornings were a regular occurrence. Early estimates show us that over ¾ of our winter salt/sand stockpile was used this season. Contractors were called upon, as needed, to assist in excess snow removal throughout Town closer to the thaw.

# Repairs & Maintenance

This year saw an increase in regular repairs and maintenance. Our "new to us" CAT grader needed a replacement intercooler. Our 2001 Freightliner needed a replacement head gasket and coolant lines. The John Deere Backhoe required work to hydraulics and hydraulic lines. Our RMT Trackless saw coolant leaks resolved. Our 2017 Freightliner saw leaky air brakes repaired. Our 2019 F-150 trucks saw significant repairs to the intake and exhaust phasers on both through Stockfish Ford. Our 2024 F-150 had a back rack, strobe light, radio and winter tires added.

# Health & Safety Training

All staff have completed some form of health & safety training as well as working at heights, chainsaw safety, and first aid. In 2025, we expect to build a training plan for staff to ensure everyone can operate all equipment safely.

#### Spring Operations

The Public Works Staff have started our annual spring maintenance program which includes street sweeping, culvert catch basin clearing, and pothole repair. Last year, short staffed, we utilized the services of external street sweeping contractor. This service was certainly valuable and gave us time to address other tasks we have put on the backburner in previous springs. We completely overhauled the public works yard, removed dilapidated structures and added 2 shipping containers for storage. This year, we have added some handheld power equipment and have a full staffing compliment to get this work done in a reasonable time.

# **Environmental Services**

#### Landfill

The landfill continues to grow and change. As we see space deteriorate, JP2G continues to monitor our next steps based on our currently expired CoA. The grinding RFQ is currently being worked on by staff and we be going out in the coming weeks.

# Recycling & Waste Collection

As we know, the recycling collection landscape is changing. Circular Materials are the chosen entity, and they are working with GFL to plan for the future of recycling collection in our community. A new recycling calendar will be produced by Circular Materials and distributed as well as new collection containers for every residence. In the new program, businesses are considered non-eligibles and considerations will need to be made as to whether the Town continues to fund business recycling or if the burden is placed on businesses directly.

#### Water & Wastewater

Our water and wastewater locations have all (but 2) had new identification signage installed. This signage helps inform the public as to what the function of the location is as well as to ensure they understand the importance of that location. Our water and wastewater infrastructure are critical and should be seen as well cared for and clean. The work to repair the roof on the water treatment plant has been started and should see completion in the next couple of weeks. We will continue to work with OCWA to ensure both the inside and outside of the plant is well maintained and in alignment with standards expected by the province.

# Water & Wastewater Training

With a member of staff retiring, we will be looking to have new staff trained to operate in water and wastewater. In 2025, a regular training log will be kept helping ensure trained water staff are meeting the training requirements established by the province.

# **Parks and Recreation**

#### Staffing

On Monday, March 31st, our new Parks & Recreation Supervisor started. Over the first few days, they were brought up to speed with the operations of many of the Town's departments. Understanding operations that are outside parks & recreation is crucial to the Supervisor's function. Over the next few weeks, we will go over the processes and procedures, pass on contact information of essential supports, and discuss how we move many of the various projects and expectations forward.

# Health & Safety Training

All staff have completed mandatory health and safety training, first aid, and more. Our training plan for 2025 will include looking at refrigeration qualifications for new staff to parks and recreation.

# Spring & Summer Youth Programs

Planning for the spring and summer youth programs has begun. We hope to offer a similar program to last year with expanded ages for daily drop-in.

# Fitness Centre

We are currently in the process of repairing water damage in the fitness centre. The water damage was caused by rapid spring thaw and overground water penetration at the basement windows and foundation.

The drywall will be repaired, the fitness centre will be painted, and carpeted floor in the stretching room will be replaced.

# Timmins, Annie's, & Gordon Dufoe Parks & Mattawa Island

Parks & Recreation staff will do seasonal maintenance on all parks once the snow has completely melted. Playground inspections will be completed and splashpad and public washrooms will be ready for summer.

#### Mattawa Waterfront

Dock repairs will soon be started. These repairs are remedial repairs to ensure we can keep the dock system operational for the 2025 season.

The final touches on the children's entertainment, vendors, and more will occur over the next few weeks. With all our main stage music acts booked, our ticket sales are over 1000 and growing. A more detailed report will be shared in the coming weeks.

# **Beautification**

In recent weeks, myself, Laura Ross, and Vicky Wilson have met to discuss beautification opportunities in and around Town. These regular meetings work very well to create a great space for collaboration and ideas. Moving forward, our Parks & Recreation Supervisor will be at these meetings and will be a great conduit for making some necessary upgrades around town.
